☒ parliamentary procedure or negotiations: 1. In November 2023, the Commission published a proposal for a Regulation establishing an EU Talent Pool 2. The dossier was referred to LIBE as lead committee and to BUDG, CULT and EMPL for opinion (EMPL rapporteur Marianne VIND, S&D). 3. On 14 February 2024, a hearing with several stakeholders was held during an EMPL committee meeting. On the same day, LIBE shared the information that the LIBE rapporteur - in the absence of a majority of the political groups supporting the timetable for this file - had decided that the vote in LIBE should not take place during the 9th term. 4. The draft opinion of the EMPL rapporteur was published on 19 February. 5. The Council adopted its general approach on the Commission proposal on 13 June 2024. 6. Following the revision of the RoP regarding conflicts of competence, the file falls under the transitional arrangements. On 26 September 2024, EMPL requested that the proposal should be dealt with under the joint committee procedure pursuant to Rule 59 (see Chair's letter attached). However, in its recommendation to the CoP of 10 October, the CCC suggested LIBE to remain the sole Committee responsible, with Committees for opinion under Rule 57: EMPL, DEVE, and CULT. The CoP decided to endorse this recommendation during their meeting of 24 October 2024.
